

## TERMS AND CONDITIONS

### CSR GYPROCK & RONDO PROMOTION 2021

1. Information on how to enter, mechanics of entry and prizes form part of these Conditions of Entry. Entry into the promotion is deemed acceptance of these Conditions of Entry. Entry is via Gyprock Trade Centre stores only.

#### PROMOTIONAL PERIOD

2. The promotion commences at **6:00am** (AEST) on **06/09/2021** and ends at **17:00pm** (AEDT) on **14/11/2021 (Promotional Period)**.

#### ELIGIBILITY

3. Entry is only open to residents of Australia aged 18 years or older who enter into a Transaction for an Eligible Product for their own direct benefit, or as the owner or director of a business or commercial entity that will utilise the Eligible Product in the ordinary course of business (**Entrants**). Employees or contactors of Entrants may enter on behalf of an Entrant, but must state the name of the business or entity upon their Entry.
4. The directors, management and employees (and their immediate families) of the Promoter, its related entities, printers, suppliers, providers and agencies whom are directly associated with the conduct of this promotion are ineligible to enter the promotion. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step- grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.

All sales will be captured on your account and entries will be collated automatically) (**Eligible Customers**). Only one transaction per day (Highest invoiced amount that day), per account will be entered.

- b. For spends of **AUD\$250-\$499 (including GST)** 2 entries will be given. For spends of **AUD\$500-\$999 (including GST)** 3 entries will be given. For spends of **AUD\$1,000 or more (including GST)** a maximum of 5 entries will be given.

Please retain a copy of the Eligible Purchase(s) valid receipt number and/or sales order number (**Proof of Purchase**).

6. Multiple Entries are permitted, however each Entry must be based on a separate Transaction, with a maximum of one (1) Entry per Entrant per calendar day permitted, per account. Each Entry must independently comply with these Conditions of Entry. For the avoidance of doubt, purchases of Eligible Products in separate transactions cannot be combined to form an Eligible Purchase.
7. Selection of **Eligible Products** is subject to availability. All products within the Rondo range are deemed to be eligible products. However not all Eligible Products may be available for sale in all participating Gyprock Trade Stores at all times during the Promotional Period. The Promoter accepts no responsibility for any Eligible Products being unavailable at a participating Gyprock Trade Store during the Promotional Period.
8. Each Entrant must retain and may be required to present Proof of Purchase of each Eligible Purchase in order to claim a prize. An Entrant may be required to provide to the Promoter Proof of Purchase for all Entries made, upon request by the Promoter. 33.
